

REGISTERING TO TESTIFY

A witness who is not invited by the committee to testify needs to register to appear as a witness. An individual who desires to testify before a House committee is required to register electronically the day of the hearing before the hearing concludes. The procedure for registration can be found at https://mytxlegis.capitol.texas.gov/hwrspublic/about.aspx. This link includes the procedure to follow as well as a map of registration locations. It also provides information on how to register via a mobile device connected to the Capitol wi-fi and a video demonstration. For Senate hearings, registration for a position on a bill (FOR or AGAINST) or to submit written testimony (40 copies) is completed at the kiosks like registering for House testimony. However, if you wish to offer live testimony, you must complete a PAPER witness card, usually found outside of the committee hearing room, and submit it to the Clerk in the hearing room. REMEMBER: WHEN YOU REGISTER, YOU ARE REGISTERING AS AN INDIVIDUAL. YOU ARE NOT REGISTERING AS A MEMBER OF YOUR CLUB OR OF TFRW (NOT REGISTERING ON BEHALF OF AN ORGANIZATION).

TESTIFYING

Be prepared because you ordinarily will only have 2-3 minutes to testify. When testifying, always begin by introducing yourself. Inform the committee whether you are testifying "for," "against" or "on" the bill. "On the bill" means that you are simply providing more information on the issue being discussed and not asking the committee members to vote yes or no on the particular bill.

Always be respectful. Do not address a committee member by his/her first name. Refer to the committee members by addressing them as "Representative" or "Senator." If a Representative or Senator chairs a committee, always refer to him/her as "Chairman" or "Madame Chair."

When it comes to questions, a witness does not ask questions of committee members when testifying. Committee members may ask witnesses questions at any point during their testimony. If you do not know the answer to a question, simply tell the member that you will get back to them. Then make sure to follow up with his/her office in a timely manner. Do not attempt to answer a question that you are not sure about.

You may be permitted to submit written testimony in support of your position. Make at least 20 copies and submit to the committee clerk. Some committees may not allow you to submit written testimony only, so be prepared to speak, even if briefly.
